

Part 1

Activities Permitted

In pursuance of the powers conferred on it by the Waste Management Act 1996 and the Waste Management (Facility Permit and Registration) Regulations 2007 (SI No.821 of 2007), Louth County Council hereby grants a reviewed waste facility permit, Waste Facility Permit Register No WFP-LH-11-0002-02, under article 35 of the regulations to Lenviron Ltd T/A Leinster Environmentals, with an address at Clermont Park, Haggardstown, Dundalk, Co Louth to carry on at premises at Clermont Business Park, Haynestown TD, Haggardstown, Dundalk, Co Louth waste activities listed below subject to the conditions and schedules set out in the permit.

Permitted Activity in accordance with the Third Schedule, Part 1 of the Waste Management (Facility Permit and Registration) Regulations 2007

| Class 10 | Recovery of waste (not mentioned elsewhere in this part of the third schedule), other than hazardous waste or an activity specified in Category 5 of Annex I of Council Directive 96/61/EC, where – |

| | (a) the annual intake does not exceed 50 000 tonnes, and (b) the maximum quantity of residual waste consigned from the facility for onward transport and submission to disposal at an authorised facility shall not exceed 15% of the annual intake. |

Permitted Recovery Activities in accordance with the Fourth Schedule of the Waste Management Act 1996

| Class R12 | (Principal Activity) Exchange of waste for submission to any of the operations numbered R1 to R11 (if there is no other R code appropriate, this can include preliminary operations prior to recovery including pre-processing such as, amongst others, dismantling, sorting, crushing, compacting, pelletising, drying, shredding, conditioning, repackaging, separating, blending or mixing prior to submission to any of the operations numbered R1 to R11). This activity is limited to the pre-processing of wastes at the facility prior to off-site recovery. |

| Class R13 | Storage of waste pending any of the operations numbered R1 to R12 (excluding temporary storage (being preliminary storage according to the definition of "collection" in section 5(1)), pending collection, on the site where the waste is produced). This activity is limited to the storage of wastes for recovery at the facility. |
